What to Wear

Wear comfortable pants

Short or long sleeve shirts

Closed toe shoes (similar to tennis shoes or comparable)

*Hat recommended but not required

What to Bring

- Notepad and Pen for notes
- 50 rounds of ammo (prefer non-hollow point, but if that is what you have bring it)
- Holster
- Ear protection (you can get a 3 pack of Hart corded ear protection from Walmart for \$4.97)
- Eye Protection (This can be your regular glasses or sunglasses or clear eye protection)
- Firearm – approved calibers are
 - 9mm
 - .40
 - .32
 - .38
 - .45
 - .380

SPECIAL NOTES

- Firearms must be unloaded before arriving at the training complex.
- DO NOT exit your vehicle with a firearm.
- WAIT (stand outside your vehicle) for a trainer (wearing a red polo shirts) to come to your vehicle to check and secure the weapon.
- DO NOT bring anyone who is not already registered for the class. Unauthorized persons will be asked to leave
- REMEMBER this is a FAMILIARIZATION CLASS, the sole purpose of this class is to assist you in becoming familiar with YOUR weapon so that you can use YOUR weapon in an emergency situation.

Alabama, **Alaska***, Arkansas, **Arizona***, **Colorado***, **Florida***, Idaho, Indiana, Iowa, Kansas, Kentucky, **Louisiana***, Maine, Michigan, Mississippi, Missouri, Montana, New Hampshire, North Carolina, North Dakota, Ohio, Oklahoma, Pennsylvania, South Carolina, South Dakota, Tennessee, Texas, Utah, **Virginia***, West Virginia, **Wisconsin***, and Wyoming.

NOTE: Alaska, Arizona, Colorado, Florida, Louisiana, Virginia and Wisconsin recognize only those Georgia licenses issued to persons twenty one years of age or older.

CAUTION! Georgia weapons license holders should familiarize themselves with the individual requirements and limitations on Georgia weapons licenses in any of the states where they may wish to exercise their rights. Weapons laws vary from state to state and there may be municipal or county ordinances regulating weapons in other states. Also, please note that states may honor Georgia licenses in regard to firearms while not recognizing licenses as to other weapons, such as knives.
